

REACTA 2018 Scholarship Fund Application Packet

REACTA, the Retired Employees Association of the California Teachers Association is an organization that works with CTA Employee Unions and CTA Management to advance, protect and enhance the pension and health care benefits of all employees who retire from the California Teachers Association. We are awarding up to three scholarships in the amount of **\$2000** each, to students currently attending or planning to register for an accredited degree granting institution or college.

APPLICANT MUST BE A CHILD, GRANDCHILD, GREAT-GRANDCHILD, NIECE OR NEPHEW OF AN ACTIVE REACTA MEMBER.

APPLICANT SHALL BE RATED ON THE INFORMATION PROVIDED IN THE FOLLOWING AREAS:

1. Personal Data Form: 10 Pts.
2. Essay on Public Employee Unions: 5 Pts.
3. Transcripts: Academic Performance: 10 Pts.
4. Letter of Recommendation #1: 5 Pts.
5. Letter of Recommendation #2: 5 Pts.
6. Leadership in School/Community: 10 Pts.
7. Application Presentation: 5 Pts.
8. Signed, Dated Release Certification Release.

Applicant must receive a minimum of 35 Points to be considered for Scholarship.

RECOMMENDATIONS: From school, work supervisors, or other individuals who are well acquainted with the applicant and can attest to the applicant's potential for intellectual and personal growth, motivation to succeed and leadership ability. Family members are not allowed to write letters of recommendation.

DEADLINE for the scholarship application is February 28, 2018. Applications postmarked after this date will not be considered.
